**2. PROPOSED TERMS OF COLLABORATION**

1. Both the institutions shall evolve a mutually acceptable schedule for guest lectures and relieve teacher of respective subjects for the same.
2. Invitation letter for guest lecturers shall be give to the teachers at least 15 days in advance.
3. Travelling expenses shall be burns by the teachers/ students.
4. No allowance shall be paid to viding teacher/ students.
- 5.The host institute shall make all the necessary arrangements for the guest lecture.

**3. NON EXCLUSIVITY**

The relationship of the parties under this MOU shall be nonexclusive and both parties are free to pursue other agreements or collaborations of any kind.

**4. TERMS OF TERMINATION**

This MOU, unless extended by mutual written agreement of the parties, small expire 5 years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 Days' prior written notice to the other party.

**5. RELATIONSHIP**

Nothing in this MOU shall be construed to make either of the parties a partner, an agent or a legal representative of the other for any purpose.
